MODERN SLAVERY POLICY

Introduction

MCS Group are absolutely committed to combating slavery and human trafficking within its organisation and its supply chains and to ensuring that it does business in an ethical manner and with respect for its people and the communities in which they live.

MCS Group believes that this commitment will benefit its customers and other stakeholders affected by The MCS Group activities. MCS Group recognises, however, that it is but one link in a supply chain to the end user that is long and global.

We are also committed to ensuring there is transparency in our own business and in our approach to tackling modern slavery throughout our supply chains, consistent with our disclosure obligations under the Modern Slavery Act 2015. We expect the same high standards from all of our contractors, suppliers and other business partners, and as part of our contracting processes, we include specific prohibitions against the use of forced, compulsory or trafficked labour, or anyone held in slavery or servitude, whether adults or children, and we expect that our suppliers will hold their own suppliers to the same high standards.

MCS Group Policies On Slavery And Human Trafficking

MCS Group is committed to ensuring that there is no modern slavery or human trafficking in its supply chains or in any part of its business.

MCS Group Modern Slavery & Human Trafficking Policy will reflect on MCS Group commitment to acting ethically and with integrity in all its business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place anywhere in its supply chains.

Due Diligence Processes For Slavery And Human Trafficking

As part of MCS Group initiative to identify and mitigate risk it ensures that new suppliers must complete MCS Group Sub-Contractor Qualification Questionnaire prior to engagement in order to evaluate the risks of modern slavery and human trafficking.

If deemed necessary, suppliers will be visited on site, and are re-audited on or around every 3 years to ensure adherence to the MCS Group strict standards of ethically transparent supply chains.

All suppliers have been contacted to express MCS Group commitment to tackling modern slavery throughout our supply chains and have been provided with a copy of our Modern Slavery and Human Trafficking policy.

A new clause has been added to the MCS Group Standard Sub-Contract amendments and will be a condition precedent to any future sub-contractor appointments. Existing suppliers also have their Subcontractor Qualification audited and renewed every 3 years.

MCS Group is also taking steps to put in place systems to:

- Monitor potential risk areas in its supply chains
- Protect whistle blowers

MCS Group are developing the following means to measure how effective it has been to ensure that slavery and human trafficking is not taking place in any part of its businesses or supply chains:

- Business function reports
- The MCS Group supplier prequalification questionnaire completed
- Standard subcontract amendments included
- Supplier renewals reviewed
- Internal staff training and induction processes 100% achieved.
- MCS Group suppliers are obliged conduct due diligence and audit their own supply chains and report on the findings – All suppliers sent the MCS Group statement and Modern Slavery and Human Trafficking Policy annually.
